**Residential**

First 2,000 gallons	\$26.46 minimum per month
Next 2,000 gallons	\$ 10.67 per 1,000 gallons
Next 6,000 gallons	\$ 9.28 per 1,000 gallons
Next 10,000 gallons	\$ 6.38 per 1,000 gallons
All over 20,000 gallons	\$ 4.75 per 1,000 gallons

**Commercial**

First 20,000 gallons	\$206.12 minimum per month
All over 20,000 gallons	\$ 4.70 per 1,000 gallons
3/4" Tap Fee--\$1,070.00 (EFFECTIVE November 29, 2017)	Residential Deposit - \$100.00
1" Tap Fee--\$1,500.00	Rental property Deposit - \$150.00
2" Tap Fee--\$4,000.00	Multiple Residential Deposits - \$ 200.00
	Commercial Deposit - \$300.00

Bills are mailed around the last week of the month. Payment is due on the 15<sup>th</sup> of every month. If you have not received your bill by the 1<sup>st</sup> week of the month, call this office. We are not responsible for lost or misrouted mail.

A late charge (10% of current bill) will be applied after closing on the 15<sup>th</sup>. In the case the 15<sup>th</sup> lands on a weekend (Sat. or Sun.), all payments received on the following Monday before closing time do not receive the late fee. If Monday is a holiday, the same rule will apply on Tuesday.

Payments can be made by mail, our office, and a drop box is also provided for your convenience. We accept cash, check, or money order. You can also pay your bill online. All accounts have a \$ 2.75 maintenance fee.

*We are not required to send out disconnect notices, your bill is your notice!* Non-payment in 30 days will result in your water being cut off. Entire balance (Including past due amount, current amount, fees, penalties, and any other charges) must be paid in full before your water is cut back on. You must have a zero (\$0) balance. If the Authority has cut your water off, you do not have our consent to use water from our system. Use of water without our consent will result in prosecution. Tampering with meter or any locking device is against the law. There will be a \$300.00 tampering fee charged for meter tampering and charges will be filed. Balances (by account, service address, and/or name) must be paid in full to establish service or to change responsibility of service.
